## SEMEN FREEZING FEES (FOR EXPORT)

BOARD UNDER QUARANTINE (\$32.00/day) Includes care for the horse under international quarantine guidelines. Turnout in isolation paddock will be available.	\$1008.00 (every 30 days)
QUARANTINE PROCEDURES (Using ERC staff and Affiliated Veterinarian)	
<ul> <li>For the Stallion <ol> <li>While in full erection, collect cultures from the prepuce, urethral orifice, sinus and fossa flandis on days 7 (Aus), 14 and 21 of of quarantine period. This testing is for CEM.</li> <li>On Day 21 of quarantine period, blood is drawn and tested for the presence of EIA, EVA and vesicular stomatitis.</li> </ol></li></ul>	\$ 370.00
<ul><li>(3) On Days 7, 14 and 21 of quarantine period, semen samples are collected and tested for CEM and other tests for ERC purposes (semen evaluation, morphology, other bacterial pathogens).</li></ul>	\$ 350.00
Once all culture and blood tests are negative then semen freezing may	proceed.
<ul> <li><u>For Teaser Mare (if applicable)</u></li> <li>(1) Culturing the clitoral fossa and sinuses, endometrium of uterus, and cervix on Days 7, 14 and 21 of quarantine period.</li> </ul>	\$ 100.00
QUARANTINE LABORATORY FEES Includes shipping and processing of at least 12 culture samples (21 if teaser mare is used), 3 blood samples and 2 semen samples.	\$ 575.00 - 950.00 (w/mare)
STATE FEES Includes state veterinarian inspection of facility and procedures	\$ 575.00
SEMEN FREEZING (UNDER QUARANTINE) Includes semen processing and freezing from one collection under international quarantine guidelines.	\$ 370.00/collection
BREEDING DOSE This fee only applies if the semen is deemed acceptable for export. This is based on ≥30% progressive motility upon post-thaw evaluation.	\$ 10.50/dose
